I hereby acknowledge I have voluntarily applied to participate in and/or observe the sport of Cowboy Action Shooting ${ }^{\mathrm{TM}}$ and/or related activities including, but not limited to, children's games, entertainment, food service, and merchandise vendors.

AS LAWFUL CONSIDERATION of being permitted to enter upon the premises upon which this event is conducted and of being permitted to participate in or observe activities or otherwise use the facilities, I, the Undersigned, for my heirs, distributes, legal representation, next of kin, and assigns, agree to the provisions set forth below:

1. I hereby release, waive, discharge, and covenant not to sue, make a claim against the property of, or otherwise prosecute Bear Creek Volunteers, LLC, its affiliate organizations, its officers, directors, shareholders, agents, and/or employees (for all purposes collectively referred to herein as "RELEASEES") for liability on account of damage to the property of or injury to the person or death of the Undersigned, whether caused from the passive or active negligence of RELEASEES or otherwise while the Undersigned is participating in or observing the sporting or related activities being presented by RELEASEES.
2. I hereby agree to Indemnify and save and hold harmless the RELEASEES and each of them from any loss, liability, damage or cost Undersigned may incur due to the presence of or any act of the Undersigned while the Undersigned participates in or observes the sporting or related activities being presented by RELEASEES, whether caused by the passive or active negligence of RELEASEES or otherwise.
